Osiguranje važi samo na teritoriji Republike Srbije.

In order to obtain residence in Serbia, you need a voluntary health insurance policy issued in Serbia. Generali Osiguranje Srbija offers a simple and easy way to ensure your health during your stay in Serbia.

Quickly and easily, without complicated procedures and from only 10 euros a month, Generali osiguranje Srbija a.d.o. will settle the costs of transport and inpatient and outpatient treatments in case of medical emergency.

Our medical health policy covers the following:

- Outpatient treatment;
- Medical supplies and medications prescribed by authorised doctor;
- Medical and technical equipment (only if it is necessary for the treatment of injuries and broken limbs, and if they were prescribed by authorised doctor);
- X-ray diagnosis;
- Surgery and related costs;
- Inpatient treatment up to 30 days.

An individual insurance policyholder may either be a legal or a natural person.

A group insurance policyholder may only be a legal person.

The insured may only be a foreign national (a person who does not have Serbian citizenship).

The sum insured is 5,000 euros.

Insurance is valid only on the territory of the Republic of Serbia.
